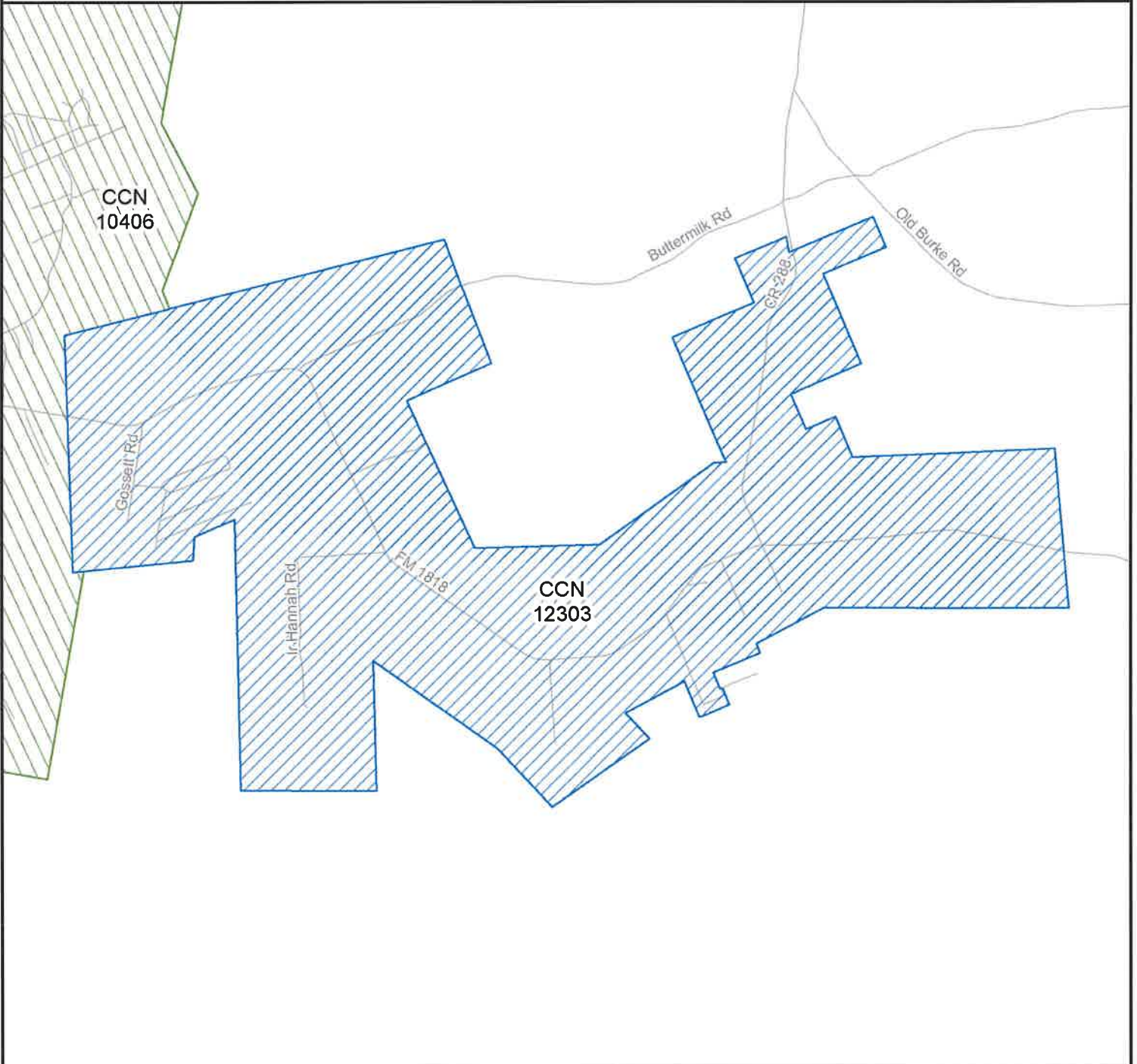

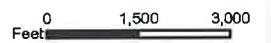

Angelina County:

Prairie Grove (PWS 0030027)

The service is located 0.91 miles southeast of downtown Diboll, Texas and is generally bounded by a parallel line approximately 2,264 feet north of the intersection of Buttermilk Road and FM 1818, by a line approximately 4,131 feet east of the intersection of CC Road and FM 1818, by Gossett Road and IR Hannah Road on the south, and by the city limits of the City of Diboll on the west. The Prairie Grove service area includes approximately 3,054 total acres and 206 current water customers.
