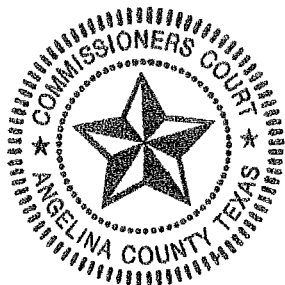
14. Judge Wright made a motion to adjourn at 10:20 A.M. Kermit Kennedy seconded the motion.
